

# ARCHERY SPECIAL USE REQUEST

I have been fully instructed in the WCW Archery Range Safety policy and procedures, and I am fully knowledgeable in shooting safety and the safe operation of all the equipment I will be using. I understand that I am personally responsible for the safe operation of this range facility and will immediately take corrective action whenever necessary to insure that everyone on the facility is following all the rules and safety procedures. I understand that display of the current membership card is mandatory and I will ask anyone on the member ranges or during member hours without a proper card and special use sticker to leave the facility. **I understand that I may not do anything other than that which the Committee has given me specific permission to do.** Shooting of birds and wildlife is strictly **forbidden** and will result in loss of all privileges.

**MEMBER HOURS** - I understand that no loud noise will be made before 9:00 AM. I understand that every person who has permission to be on the property during members hours will have a gate key in their possession and I will not admit others in to the facility. I understand that without other specific permission, I will be limited to using the walk-through and flat ranges.

**FLAT RANGE** - I understand that all shooting will be done from the established covered firing line. I understand that a range ceasefire will be conducted to pull arrows.

**WALK-THRU** - I understand that the walk-thru range is only safe when used as designed and all shooting will be done from the established firing points at the designated targets.

**FLAT RANGE LIGHTS** - I understand that the lights are for use only by members with a gate key in their possession and with permission to use them. I understand that if I am the last to leave, it is my responsibility to turn off the lights. **I understand the lights are primarily for extending the flat range shooting hours during the winter months and not for late night shooting.**

**BROADHEAD PITS** - I understand that all use of Broadhead hunting arrows are limited to the two sand pits on the Flat range.

**FITA RANGE** - I understand that all shooters on the FITA range will establish a reasonably straight firing line which is no more than 10 meters in depth across the entire field. I understand that range ceasefires will be conducted to pull arrows. **I understand that this range is limited to use by competitive target shooters using appropriate equipment.**
